

Terms of service

Your account and data

1. You are responsible for the security of your account and password.
2. You agree not to use OnFlow for any illegal purpose or violate any laws.
3. You are responsible for all content and data you upload or post to OnFlow.

5. OnFlow has the right, but no obligation, to review, refuse or remove any content available in or posted to OnFlow.

Pricing, payments, refunds, upgrading, downgrading and cancellation

1. Prices are subject to change upon 30 days notice from us.
2. OnFlow is billed in advance on a monthly basis.
3. All fees are exclusive of taxes.
4. Payment of said fees must be made full in 30 days.
5. Failure to pay outstanding fees for over 30 days may result in suspension, and eventual termination, of your account.
6. You may cancel at any time, there is no notice period.
7. All cancellations are effective at the end of the current billing cycle.
8. Your account will be inaccessible when cancellation is effective, and all associated data will be deleted after 30 days. You are responsible for exporting or migrating your data on time before your account becomes inaccessible.
9. When upgrading and downgrading, the new rate will be billed at the next billing cycle. When upgrading, the remainder of current billing cycle will be billed at the new rate. When downgrading, no refunds or credits will be issued.

Termination

1. Violation of these Terms may result in immediate termination of your account. Such termination will result in the deactivation or deletion of your account and access to your account and all associated data.
2. OnFlow has the right refuse service, to suspend or terminate your account at any time for any reason.
